<u>Enrollment Fee:</u> An annual enrollment fee of \$125.00 is due for all children with this Tuition and Enrollment Contract to hold your child's place for the academic year. It is NOT REFUNDABLE. All children must re-enroll for each academic year.

<u>Early Withdrawal Policy:</u> Early withdrawal during the academic year constitutes a breach of this Tuition and Enrollment Contract. A two-week written notice of withdrawal must be given. Tuition is still owed for those two weeks and will be pro-rated based on your tuition rate. In addition, a penalty of \$350.00 will be charged. This applies to all students.

<u>Extended Absence</u>: Tuition is not subject to adjustment because of illness, vacation/travel or extended absence, unless it is over two weeks. If the absence is over two weeks, the first two weeks' tuition is still due. Beginning on the third week and each week following, you will be charged half the tuition for that period. This guarantees the child's place upon return.

<u>Late Pickup Charges:</u> There is an hourly rate of \$12/hour if your child stays beyond their scheduled time (prior to closing time). This should be scheduled ahead of time for staffing purposes. **Additionally, a \$ 5.00 per minute fee will be assessed when a child is picked up after 6:00pm, payable directly to the teacher caring for your child. Please notify the school immediately if you know you will be arriving after 6:00pm. Regular late arrivals can result in cancellation of your child's enrollment from the program.**
